A central arrangement of the Global Compact on Refugees (GCR), this 2nd edition of the Global Refugee Forum (GRF) presents a unique opportunity for States and their national and international partners to take stock of the important human rights dimensions of secure access to housing, land, and property for refugee and returnee men, women and children and their host communities.

This event is part of the efforts towards renewed political will, resource mobilization, and additional in-kind support to address tenure-related challenges and enable sustainable pathways to durable solutions and long-term development and peace outcomes.

Drawing on the experiences of key State and non-state actors, this event seeks to reinforce an already compelling case for more predictable, equitable, and sustainable HLP responses to the HLP challenges in the context of new and protracted displacement.

Objectives



1. To highlight the depth, breadth, drivers, and consequences of insecure tenure on refugee and returnee populations and their host communities;
2. To demonstrate how comprehensive strategies for securing rights in housing, land and property are fostering resilient communities and enhancing capacity for voluntary return and sustainable reintegration, while establishing pathways to local integration; and
3. To inspire renewed political interest (at the national and subnational levels), the earmarking of resources (via various financial instruments and technical assistance programmes), and in-kind support for addressing the tenure-related challenges faced by forcibly displaced populations and their host communities.

From the demonstrated political will and commitment of Member States, inter-governmental platforms, regional frameworks, UN system partners, and multilateral financial institutions in fostering conditions for safe and dignified returns, local integration, and other local solutions, to the broad-based peacebuilding efforts of said actors in addressing the root causes of displacement – complemented by grassroots-level conflict-sensitive, HDP nexus programming – we acknowledge the progress made towards preventing and resolving forced displacement and the resultant impact on both countries of origin and asylum, mindful that there is yet much ground to be covered.

To this end, the 2021 High Level Officials Meeting (HLOM) – mandated by the General Assembly, as per the Global Compact on Refugees (GCR) – called for increased resources and enhanced planning and programme implementation supporting voluntary returns, and improved capacities

and cooperation among key actors for addressing the root causes of forced displacement in countries of origin.

Building on the promising practices and opportunities for scaled-up engagement on safe and dignified voluntary returns and addressing the root causes of forced displacement – with an outlook to GRF 2023 – a multi-stakeholder pledge, framed against recommendations 18 through 20 of the 2021 HLOM and contributing to GCR Objective 4, has been formulated to leverage the current momentum around area-based initiatives with strong operative linkages to security of tenure in housing, land and property in countries of origin.

This pledge also brings into sharp focus, recommendations 9 through 11 of the 2021 HLOM – in relation to GCR Objective 1 on '[Easing] pressures on host countries'. Accordingly, this pledge further seeks to leverage new and emerging financial instruments, funding windows and other platforms that promote equitable burden and responsibility sharing, increased development financing, and more flexible, predictable, and multi-year funding for refugee responses.

Prospective pledging entities – including Member States, multi-lateral financial institutions, development cooperation and foreign aid agencies, refugee-led, civil society and humanitarian organizations – with a vested interest in supporting conditions in countries of origin for safe and dignified returns, while promoting local integration and other local solutions are hereby invited to offer consideration towards the following.

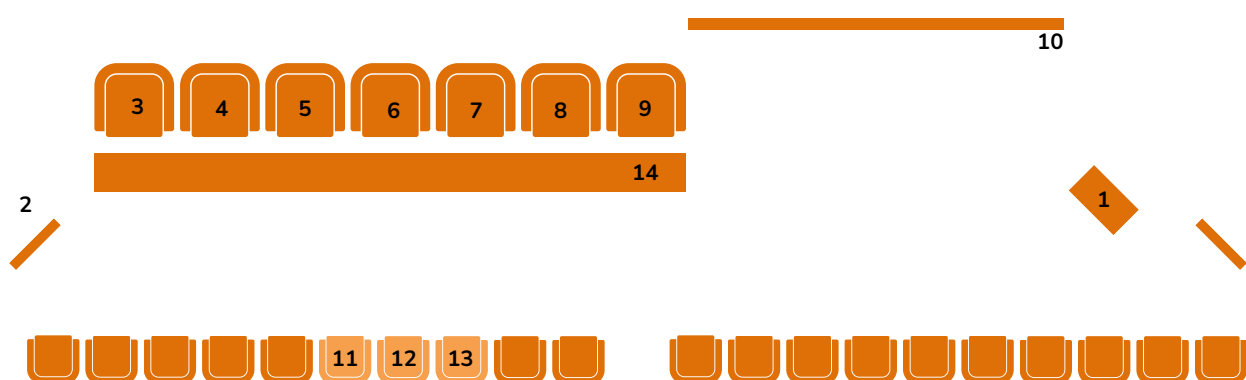

Ms. Maimunah Mohd Sharif is the Executive Director of the United Nations Human Settlements Programme (UN-Habitat) – an office held since 2017, at the level of Under-Secretary-General. Since joining the United Nations, Ms. Sharif has reformed and repositioned UN-Habitat as a thought leader in sustainable urbanization. She is a vocal advocate for the implementation of the New Urban Agenda to achieve Sustainable Development Goals and the nationally determined contributions to the Climate Action Paris Agreement.

Prior to joining UN-Habitat as Executive Director, Ms. Sharif served as Mayor of the City Council of Penang Island, Malaysia and in 2011, became the first woman to be appointed President of the Municipal Council of Seberang Perai, Malaysia.

Mamadou Dian Balde assumed his functions as the United Nations High Commissioner for Refugees (UNHCR) Director for the Regional Bureau of the East, Horn of Africa, and the Great Lakes in Nairobi, Kenya on 01 July 2023. He has also been the Regional Refugee Coordinator for the Sudan Situation since 14 June 2023.

Prior to his current assignment, Mamadou Dian Balde worked as the UNHCR Representative in Ethiopia. He was previously the Deputy Director of UNHCR's Division of Resilience and Solutions (DRS) at UNHCR's HQ in Geneva. In this capacity, he oversaw and supported UNHCR's global programmes on education; livelihoods and economic inclusion; social protection; food security; and durable solutions.

Mamadou Dian Balde has worked with UNHCR for over 24 years, with field postings in Africa (Benin, Chad, Ethiopia, Liberia, and others), and Asia (South Korea), as well as at the organization's headquarters in Switzerland. Mamadou Balde holds a Ph.D. in International Law, from the Université Catholique de Louvain and has researched and taught International Human Rights Law

Ms. Elizabeth Moreno Barco was the first woman to be elected as the legal representative of ACADESAN, a territorial council that promotes and protects the rights of 72 Afro-Colombian communities living in the San Juan region, and has served two terms of office since 2015. She also serves as the coordinator of the Chocó Solidarity Inter-ethnic Forum (FISCH), which promotes development based on ethnic culture and knowledge, while tackling issues such as forced displacement and confinement. Early this year Elizabeth was Colombia's Advocate of the Year, and won the 2023 Regional Nansen Refugee Award for the Americas.

Traveling to Cuba, she took part in the peace talks with the Revolutionary Armed Forces of Colombia (FARC), managing to get five municipalities from the region to be explicitly included in development plans. And in October 2022, she addressed the UN Security Council, giving remote video testimony about the systematic violation of their economic, cultural, social and environmental rights of the communities she represents.

Multistakeholder Pledge

Durable Solutions through Secure Housing, Land and Property Rights

This Multistakeholder Pledge effectively promotes durable solutions with a primary emphasis on sustainable return and reintegration, local integration and other local solutions, and thereby contributes to Objectives 1 and 4 of the Global Compact on Refugees (GCR) – to ease pressures on host countries and support conditions in countries of origin for return in safety and dignity.

Firmly established in the ideals of good land governance – characterized by accessible, transparent processes that enable forcibly displaced persons to participate in decision-making on how land is used, managed, and developed, ultimately contributing to the overall recovery from conflict, peace-building and bringing displacement to an end – the pledge has been framed squarely against recommendations 18 through 20 and 9 through 11 of the 2021 High Level Officials Meeting on the GCR.

Secure access to adequate housing and land plays a critical role in facilitating access to a range of human rights, including the right to food, shelter, water, sanitation, health, work, security, freedom of movement – just to mention a few – and is therefore a key factor in addressing the human and societal impact of climate change, land degradation, desertification, food insecurity, biodiversity loss, urbanization, the differentiated experiences of men, women and children in certain parts of the world, and the consequent escalation of tensions over access to and use of land and natural resources and forced displacement.

Pledging Areas of Focus

By committing to this Multistakeholder Pledge, stakeholders agree to support the advancement of durable solutions via any of these five Key Areas of Focus:

- 1. Restitution of housing, land, and properties (For State Actors in Countries of Origin) –** You commit to ensuring that displacement affected populations can access HLP restitution mechanisms with special attention given to the rights of female-headed households and in accordance with international laws and best practice. You commit to initiate and undertake activities to facilitate restitution of housing, land and properties of returnee women, children and men with international support as required. This will include shaping policy, legal and regulatory frameworks, and providing material and in-kind support for restitution and/or compensation processes and programming in accordance with international law and best practice.
- 2. Recognized documentation of tenure rights to housing, land, and properties (For State Actors in Refugee Hosting Countries and Countries of Origin) –** You commit to initiating and undertaking activities with international support as required towards the provision and

safeguard of recognised documentation of formal, customary and informal HLP rights of refugee and returnee women, children and men as a central facet of housing and land programmes.

- 3. Comprehensive strategies for securing rights to housing, land and properties (For State Actors in Refugee Hosting Countries and Countries of Origin)** – You commit to initiate and undertake activities towards the development and implementation of comprehensive adequate housing and land tenure security interventions in support of women, children, men and communities affected by displacement through area-based approaches and with support of national and international humanitarian, development and peace actors as required.
- 4. Material support for initiatives promoting secure housing, land, and property rights for forcibly displaced persons (For Donor States, Inter-Governmental Bodies, International Financial Institutions, other development actors – including UN System Partners)** – You commit to support refugee hosting states and countries of origin to address the barriers to secure access to adequate and affordable housing, land and property for forcibly displaced women, children, and men by way resource mobilization via earmarked financial instrument and in-kind support and other forms of material support.
- 5. Technical support for initiatives promoting secure housing, land, and property rights for forcibly displaced persons (For UN System Partners, development actors, international non-governmental, civil society and refugee-led organizations)** – You commit to support refugee hosting States and countries of origin in addressing the barriers to the enjoyment of housing, land and property rights for forcibly displaced women, children, and men by way of technical assistance, support in coordination and other forms of in-kind support, including via development cooperation programming.

Organizers and Pledge Conveners



UNHCR, the UN Refugee Agency, is a global organization dedicated to saving lives, protecting rights and building a better future for people forced to flee their homes because of conflict and persecution. The agency is furthermore mandated to lead inter-national action to protect refugees, forcibly displaced communities and stateless people.

Formally known as the Office of the High Commissioner for Refugees, UNHCR was established by the General Assembly of the United Nations in 1950 in the aftermath of the Second World War to help the millions who had lost their homes. Today UNHCR works in 135 countries – providing life-saving assistance, including shelter, food, water and medical care for people forced to flee conflict and persecution – and defends the right of such peoples to reach safety and in finding a place to call home. UNHCR supports countries in improving and monitoring refugee and asylum laws and policies, ensuring human rights are upheld.

Centrally, UNHCR considers refugees and those forced to flee as partners, putting those most affected at the centre of planning and decision-making.



The United Nations Human Settlements Programme (UN-Habitat) is mandated by the UN General Assembly to promote socially and environmentally sustainable towns and cities, and serves as focal point for all urbanization and human settlement matters within the UN System.

UN-Habitat works with partners – including governments, intergovernmental bodies, UN agencies, civil society organizations, foundations, academic institutions and the private sector – to build inclusive, safe, resilient and sustainable cities and communities, and promotes urbanization as a positive transformative force for people and communities, reducing inequality, discrimination and poverty.

With a global footprint spanning more than 90 countries – promoting transformative change in cities and human settlements through knowledge, policy advice, technical assistance and collaborative action – UN-Habitat has adopted a strategic and integrated approach to solving the challenges and opportunities of twenty-first century cities and other human settlements. UN-Habitat's mission embodies the four main roles of the organization, which can be summarized as: think, do, share, and partner.



The Norwegian Refugee Council (NRC) is an independent humanitarian organisation helping people forced to flee. With relief efforts dating back to the post World War II era, NRC works to protect displaced people, supporting them in rebuilding their lives.

Specialising in six areas – food security, education, shelter, legal assistance, protection from violence, and water, sanitation and hygiene – NRC works in both new and protracted crises across 40 countries, working with partners across the world through NORCAP – their global provider of humanitarian, development and peacebuilding expertise – which collaborates with local, national and international partners on finding sustainable solutions to meet the needs of people at risk.

NRC is a determined advocate for displaced people, standing with those forced to flee – promoting and defending displaced people's rights and dignity in local communities, with national governments and in the international arena. NRC's Internal Displacement Monitoring Centre (IDMC), located in Geneva, Switzerland, is a global leader in monitoring, reporting on and advocating for people displaced within their own country.

Secure housing, land and property (HLP) rights are essential to the attainment of durable solutions and long-term development outcomes – cutting across the humanitarian, development and peace-building agendas.

This high-level side event therefore marks a key juncture in our joint efforts to promote scaled-up global engagement among humanitarian and development actors in support of refugees, refugee returnees and their host communities, through State-led initiatives programmed with an outlook to inclusion and solutions.
